

## GE Centricity EMR and Centricity Practice Solution EMR Clinical Consultant Certification Process



The Clinical Consultant Certification Process is designed for clients who resell licenses and implement the Centricity Practice Solution EMR (SQL) and Centricity EMR (Oracle) Software directly to their customers. The Certification Process offers implementation support and quality assurance to ensure customer success.

The **Certification Process** requires:

- Online Course Registration at <http://cpstraining-gehc.com/joomla/>
- Attend pre scheduled Coach Check Points with assigned Mentor
- Completion of Certification Level Courses and Tutorials
- On the Job Training by providing Implementation Services to Clients
- Participation in Online Training Center (OTC/ Angel) Modules and Collaboration
- Successful completion of the GE Clinical Assessments (upon which a certificate is granted)
- Continued Knowledge Share/Collaboration for Implementations and Upgrades through the OTC

### Coach Check Points

Once your registration is processed, you will be assigned a Mentor and a log on and password for access to the Online Training Center (OTC/ Angel). Your Mentor will be available by teleconference to answer questions on the course content, guide you through the initial process, and provide additional learning opportunities. Two Mandatory Meetings will be pre-scheduled upon the beginning of the Program, and at the completion of Tutorials. You will be able to reach out to your mentor via email as needed and request additional meeting times.

\* These tutorials are also available as a 3 day Instructor Led Course CPS EMR Functionality (EMR 101). An additional cost of \$4200.00 applies. A Test Out Option is also available for these courses, as well as CPS EMR/ Chart Module Set Up for a flat rate of \$500 per candidate.

The following **Certification Level Courses** are required to be completed with a passing score of 90%:

- CPS EMR/Chart Module Setup (EMR 102)
- Clinical Consulting Methodologies (EMR 103)

After completing the courses, you will be ready to implement Centricity Practice Solution EMR Software. Approximately 30 – 45 days after your first three clients have been live, GE Healthcare will schedule **Client Assessments** to evaluate their understanding of clinical workflows, performance, and database settings. Once the Implementation has been deemed successful, feedback will be provided to you regarding the client assessment and certification will be granted. You will also have continued access to the **Online Training Center (OTC/ Angel)** where you can collaborate on best practices, and complete tutorials on New Software Releases during the period of your certification.

**Maintaining Certification** is accomplished through posting of White Papers and/or Completion of Self Paced Tutorials on New Software Releases for the current year.
